Background

The European Meetings of People experiencing Poverty have played an important role in driving the development of the direct participation of people experiencing poverty. The European meeting is a key visible moment in this process but as important is that it acts as a catalyst for national process and meetings of people experiencing poverty. The European Meetings have been well documented and positively evaluated for their impact on the delegates and the guests who attend.

The meetings have contributed to keeping poverty and social exclusion visible in the European agenda and they have contributed to some key areas of policy development such as adequacy of minimum income, child poverty, housing and homelessness, indebtedness, the links between discrimination and poverty (particularly the realities for Roma community), and the impact of liberalization on public services and the EU poverty reduction target. In addition the meetings provide a 'barometer' in relation to social and economic developments in Europe. The processes associated to this meeting assist in the journey from 'people experiencing poverty' to 'activists with direct experience of poverty' and past participants are now playing important roles in anti-poverty organisations.

The meetings were developed as EU Presidency events and were conceptualized as an important part of the Social OMC, responding to the agreed objective 'to ensure the direct participation of people experiencing poverty and social exclusion'. However the reality in the last years is that the national stakeholder processes associated to the Social OMC have diminished and it has been difficult in most countries for people experiencing poverty and their organisations to access the processes associated to the Europe 2020 strategy. In addition fiscal consolidation and austerity approaches means that the reality for people experiencing poverty is worsening and the numbers in poverty are growing. All this has led to a growing sense that the format for the European meetings needed to change.

2013 Meeting

The 2013 meeting will be organized by EAPN with support from the European Commission, the Irish Presidency of the EU and the EAPN Fund. The meeting will be held in a temporarily constructed Conference Centre on the Esplanade directly in front of the European Parliament. Support for the use of the Esplanade has been received from the

European Parliament's Committee for Employment and Social Affairs. This year's meeting will have a less formal format and will have more elements of cultural exchange. The meeting is seen as an important event in the calendar of the 2013 European Year of the Citizen.

However the meeting remains a meeting of people experiencing poverty where they directly 'take the floor' and the desire to interact with politicians and Institutional actors remains an important part of the event. It is very important that the meetings continue to be seen as an important part of the EU Inclusion Strategy and contributes to the Social OMC and the Europe 2020 Flagship initiative 'Platform against Poverty' and the recent Commissions Communication on the Social Investment Package.

Objectives for the 2013 Meeting

- To reinforce the visibility of the fight against poverty and social exclusion in Europe.
- To recognise the courage, commitment and expertise that people experiencing poverty bring to the fight against poverty and to foster commitment to developing the participation of people experiencing poverty and social exclusion.
- To make visible the links between the different levels; local, national and European and the need for coherence between the different levels.

Content of the exchanges at the 2013 Meeting

The recent Commission Communication 'Towards social Investment for Growth and Jobs' which was released as part of its Social Investment package calls on members states to fully implement the Recommendation on Active Inclusion (2008) integrating its three pillars, adequate income support, inclusive labor markets and enabling services. The Communication commits the Commission to develop in 2013 a common methodology for reference budgets as part of the monitoring of adequacy of income supports.

The exchanges at the 2013 meeting will contribute to this objective by 1) exchanging on what should be part of an essential basket of goods and services to be used in reference budgets, 2) exchanging on what are the current developments for individuals and communities in terms of the three pillars of the Active Inclusion Recommendation and 3) Exchanging on practices that people experiencing poverty and their organisations are developing to fight poverty and exclusion and what is helping and hindering the implementation of these practices.
