### **3) Objectives of your Organisation**

Main objectives

The Emmaus movement was founded by Abbé Pierre in 1949. Emmaus Europe is a federation of Emmaus organisations in Europe. Its objectives are to reinforce and safeguard Emmaus' identity in Europe in order to combat all forms of exclusion, social, racial, political, economic, religious, philosophical, ethnic and other types of discrimination, and in order to ensure that the rights of the poorest people in Europe and worldwide are recognised and exercised. Emmaus Europe also aims to act as a liaison and mutual support body for the members of Emmaus in Europe, while respecting their individual characteristics and independence, contribute to and ensure that the work of our members complies with Emmaus International policy and specifically with its fundamental texts and General Assembly decisions.

Outline of interest in and work on anti-poverty issues

Emmaus Europe undertakes the following tasks: lead the region's member organisations; organise policy-related, economic and social training for Emmaus stakeholders in the region in order to equip them to play their advocacy role at local, national and regional level; gather all the information needed to develop the movement's campaigning stance so that it can be conveyed to the region's member organisations and contribute the ideas needed to ensure that the Emmaus International working groups function properly.

Emmaus Europe also lobbies the public authorities and European political authorities, forms alliances with other European organisations which share the same aim in order to fight together against extreme poverty and its causes in all parts of the world and particularly in Europe. And examines, adopts and monitors regional solidarity initiatives put forward by members of the region.

## **6) Expectations of the European Anti-Poverty Network (EAPN)**

Why do you want to join EAPN? What's your organisations motivation?

Emmaus Europe recognises that joining forces with Networks of organisations who share similar values to ours can enhance our ability to achieve on our organisational objectives and support the work that we do.

One recent example of this would be the EU's planned Circular Economy Directive. Our concern with this legislation was that it risks favouring commercial operators in arenas of resale and reuse of furniture and other items that brings income to our communities and provides meaningful activities for the people these communities support.

By joining and collaborating with the European [RReuse Network](#) our collective efforts have secured amendments to the Directive that we hope will protect the Social and Solidarity elements of a proposed Circular Economy.

Emmaus Europe is also working in partnership with [Migreurop](#) to address issues that arise from the EU Migration Policies that impact on our work.

We feel that similar opportunities can exist with our joining the EAPN to address the wider roots of poverty and the associated social exclusion that can result.

### **7) What can you bring to EAPN?**

Emmaus Europe represents a pan-European secular, socially responsible and non-violent movement which is independent from any form of power. The movement aims to defend the most destitute members of society and we hold a wealth of good practice and examples of grassroots solutions to some of society's most pressing issues.

Emmaus Europe, in its current form, was created on 21st May 2005. A not-for-profit organisation, it brings together all the Emmaus structures in Europe and is one of the four continental regions of the Emmaus Movement (Africa, America, Asia and Europe).

Today, 309 groups in 17 European countries are members of Emmaus Europe and we feel adding these voices those of the EAPN will create a power force for change.

Campaigning for and championing the rights of 'those who suffer most' in society form the foundation of the Emmaus Movement.

Since the beginnings, the Movement founded by Abbé Pierre has challenged injustice and inequalities in society. This has been grounded by practical actions not just rhetoric and 'good intentions'.

### **Strategic planning and thinking**

The Regional Council is Emmaus Europe's political decision-making body.

The Regional Council is tasked with boosting and monitoring all the organisation's decision-making bodies, including the Regional Executive, with Emmaus Europe's work being placed under the direct responsibility of the Regional Council.

The Regional Council implements the strategic areas, proposals and decisions approved at the World and Regional Assemblies.

In Europe, the Regional Council provides a concrete scope for the values advocated by Emmaus:

- fighting for the rights of the poorest members of society.
- solidarity initiatives and initiatives to combat exclusion.
- fighting extreme poverty and the causes of extreme poverty.

The Regional Council also organises Emmaus Europe's communications policy targeting the general public and the public authorities in order to more successfully defend the principles of the Emmaus Movement.

Finally, the Regional Council promotes the development of the Emmaus Movement in Europe.
