Dear President,

The Emmaus groups are confronted on a daily basis by human distress in Europe **and including people is an important component of Emmaus' work in Europe**, with the aim being to develop humane solutions commensurate with the migration topics.

The Emmaus ragpickers' traditional activity has evolved and now encompasses not only the textiles sector but also WEEE and furniture waste. In accordance with the Emmaus Movement's values of simplicity and solidarity, the Emmaus companions and employees recycle and reuse, giving a fresh lease of life to second-hand goods, thus helping to manage the ever-increasing amount of waste generated by our consumer society.

Emmaus is therefore at the very heart of sustainable development with its three pillars: environmental, social and income-generating work.

Moreover, Emmaus is unique because of its social impact - its waste management and recovery work enables social ties to be forged by creating jobs and reintegrating socially-excluded people into the world of work. This work enables men and women to make a decent living from their work while being proud of helping those who suffer most. **Solidarity is therefore at the heart of Emmaus' work. We do not sell all of the goods that we collect: some are donated to the most disadvantaged and vulnerable people, the homeless, and migrants. This practice of intensive solidarity aims to implement Emmaus' core values, while endeavouring to respond to the current social and environmental crises.**

Since 2009, Emmaus Europe has been raising the profile of the practices implemented by the European member organisations. A number of resources have been created and then circulated internally in order to continue developing alternatives while sharing practices.
