



Evolution of poverty during the last decade:



No progress to the EU2020 poverty-target
AROP (2019): 14.8% - almost 1.7 million people



Impact of the covid-crisis: People with a low income have been hit the hardest

- Pressure on household budget: loss of income, increase of prices (e.g. food), lack of savings
- **Lack of access to services**
- **Consequences:**
 - Increase of debts
 - Medical issues
 - Mental health issues
 - **Effects on children and young people**
- **Lack of perspective**





Social protection (Income)

Social Scoreboard indicator 'impact of social transfers on poverty reduction': worrying decline of effectiveness of social transfers on poverty reduction

Minimum income schemes still remain far below the European poverty threshold



Social protection (Income)

Problems with access to Minimum Income Schemes, some groups are even excluded

Statute "cohabitant" : This statute reduces benefits in a way that is disproportionate to what people can actually save by living together. The status also seriously curtails the rights and liberties of those classified as living together.



Policy analysis of (income) measures taken by the federal government

- □ Budget federal task force "vulnerable groups" (€75 million):
 - **not enough to combat a social crisis**
 - Covid-allowance not enough, groups excluded

Plans to increase minimum income schemes: too little, too late?!






Policy analysis of (income) measures taken by the federal government

Resilience and recovery plans:

- ❑ No consultation of anti-poverty organisations or CSOs
- Process not transparent
- Vision to combat social exclusion seems to be missing, political agreement





Questions to the EU level:

- EP Intergroup on poverty: role to support a strong implementation plan of the EPSR?
- **European Commission:**
 - **Follow up on Council Conclusion on Minimum Income?**
 - Recovery and resilience: involvement anti-poverty organisations and CSOs / vision on social inclusion ?
 - Evaluation of Europe2020-strategy?
 - **European ant-poverty strategy?**
