EAPN ANNUAL REPORT ACTIVITY 2010

PRESENTED TO THE GENERAL ASSEMBLY (JUNE 2011)

1) Context for EAPN's work in 2010

The context was shaped by three key factors:

- 2010 was the European Year for combating poverty and social exclusion. EAPN had contributed to the designation of this year and was active engaged in the activities of the year. To know more about EAPN's involvement on the 2010 Year see, www.endpoverty.eu
- 2010 was also the period when the European Institutions agreed its key strategies for the coming period, now known as the Europe 2020 strategy, the Social OMC and the Platform against Poverty. EAPN has been very active in making inputs to the development of these strategies. To see EAPN position papers and contributions see, <u>www.eapn.eu</u>
- 2010 will perhaps be best remembered as the time for the implementation of 'austerity measures' as a response to the 'on going crisis'. EAPN has highlighted the impact of the crisis on people experiencing poverty and social exclusion and have pressed for more sustainable solutions that don't make the 'poor' pay for the crisis.

2) EAPN – An overview of our work in 2010

As a membership Network the key objective of EAPN is to create the conditions where our members can effectively engage with EU actions in the field of the fight against poverty and social exclusion. Therefore we invested in ensuring that our members are well informed about such actions and have the capacity to actively engage in the development, implementation and evaluation of such actions. To achieve this we had regular communication flow to and from our members, our statutory arrangements (General Assembly, Executive and Bureau) ensured democratic accountability and we had three major working groups with involvement of representatives from our members to follow three key areas of our work, social inclusion, employment and structural funds.

EAPN is committed to the direct **participation of people experiencing poverty and social exclusion** in our work. The most visible aspect of this work is our support for the annual European meeting of people living in poverty that is part of the Presidency programme of the EU run in the first half of each year. In 2010 this event was promoted by the Spanish Presidency. This event is a catalyst to similar events within Member States and is a key driver of increased direct participation of people experiencing poverty in the work of EAPN.

Our work is aimed primarily at the EU Institutions; Parliament, Council and Commission. EAPN contributes to building a European public space to engage with these institutions

through written contributions, engagement of representatives in key conferences organised by EAPN such as the conferences held in 2010 on: 1) the Europe 2020 strategy (Dublin), 2) Poverty and social exclusion aspects of Migration (Cyprus) and 3) The importance of Adequate Minimum Income Schemes (Belgium), participation in events organised by these institutions such as: 1) the Agora on Poverty in the European Parliament, 2) the Annual Round Table on Social Inclusion and 3) Events organised in the context of the Spanish and Belgian Presidencies.

3) Main objectives and Activities in 2010

The key objectives of the actions of EAPN during this period were:

- To enable EAPN members play an active role in the 2010 EU Year for Combating Poverty and Social Exclusion so as to ensure that 2010 marks a turning point in the fight against poverty and social exclusion: Under this objective key actions included a series of focus weeks in each member state of the EU and in Norway where a programme of activities including conferences, public actions, concerts, media events were organised to highlight the need for actions to fight poverty. A Human Ring involving 3000 people was built around the European Parliament to call on the Parliament to prioritise actions to address the reality that more than 80 million people live in the EU in or at risk of poverty.
- To reinforce EAPN as a strong, participative and sustainable European Network: Actions under this objective included engaging some 906 individuals very directly in activities organised by EAPN.
- To contribute to a better understanding of the causes and consequences of poverty: Actions under this objective included three major conferences, the publication of three issues of our Magazine and an electronic news flash which is distributed almost every two weeks.
- To lobby and campaign effectively for policies and processes which deliver a social inclusion agenda: Actions under this objective included organisation and participation in conferences and seminars and 29 written contributions developed with our members to contribute to key consultations.
- To build strategic alliances to create a context more favourable to the fight against poverty and social exclusion: Actions under this objective included providing the coordination for the NGO Coalition for the 2010 Year for combating Poverty and Social Exclusion. Participation in the Platform of European Social NGOs and related groups such as the Spring Alliance (an alliance of Trade Unions and NGOs).

Key statistics on activities of EAPN at European level in 2010

- EAPN took into account 485 invitations from the invitations they received from third parties and responded positively to 319 of them, including 73 conferences/seminars where EAPN representatives were asked to speak.
- EAPN prepared 57 reports (including 28 information and promotional materials) and printed 56920 copies of these reports.
- 906 people took part in the 35 events EAPN organized (not counting the 3000 + or who took part in the Human ring around the European Parliament)
- 60844 people visited the EAPN website

4) Achievements in 2010

At a time when austerity measures, which hit the poor hardest, are implemented in response to the crisis, where there is an increase in the numbers of 'working poor' and increasing conditionality is applied to the access to social welfare, it is difficult to speak about achievements without sounding out of touch with the reality our members face in their everyday work. However despite this negative overall context there has been a number of key achievements in the last year including:

- **2010 Focus Weeks**: were organised by EAPN National Networks, in nearly all EU Member States and Norway in the context of the 2010 EU Year for combating Poverty and Social Exclusion with a huge range and variety of activities delivered (see www.endpoverty.eu)
- Human Ring around the European Parliament: To call for a lasting legacy from the 2010 Year a human ring was made around the European Parliament with the support of the 2010 NGO Coalition.
- New Commitments to keep the fight against Poverty on the EU Agenda: EAPN contributed to achieve these new commitments including: the agreement by Heads of State and Governments for a target to reduce poverty, a new commitment to strengthen NGO participation in National Reform Programmes, the Commitment to develop a Platform against Poverty and the commitment to strengthen the EU Inclusion Strategy (Social OMC).
- EAPN contributions to key strategies and policy developments: EAPN made detailed contributions on the Europe 2020 strategy, the guidelines on Employment, the Platform against Poverty, the Social OMC, the impact of the Crisis on the 'poor', as well as areas such as, Structural Funds (inputs into the future of the Cohesion Policy and strengthened engagement with DG Regio), Energy Poverty, Services of General Interest, Migration and Poverty and the need for an improved EU Directive on Discrimination.
- **Draft Directive on Minimum Income and Progress on Active Inclusion:** EAPN produced a draft directive on Minimum Income, showing the legal base and the possible content for such a directive. During 2010 as part of its work to keep alive the Recommendation on Active Inclusion, EAPN developed a video and publication on positive Activation which will be available in 2011
- **Key Conferences:** were held on the Europe 2020 Strategy, Migration and Poverty and on the Adequacy of Minimum Income Schemes.
- Enlargement of the EAPN Network: the Estonian Network joined EAPN and contacts were further developed in: Latvia, Iceland, FYR Macedonia, Turkey and Serbia.
- Communication: EAPN improved the presentation of its key documents (see: <a href="http://www.eapn.eu/index.php?option=com_content&view=category&layout=blog&id=42<emid=82&lang=en">http://www.eapn.eu/index.php?option=com_content&view=category&layout=blog&id=42<emid=82&lang=en). It also continued with its Explainer series, developing an explainer on Adequacy and one on Wealth. It produced three issue of the EAPN Magazine and continued to distribute fortnightly electronic 'news flash' that are publically available. We also regularly updated our website www.eapn.eu
- **Development Work:** In this period EAPN has developed its work on participation of people experiencing poverty (a second publication is being developed), we also concentrated more on trying to develop more sustainable funding to support the work of our members and set up an EAPN Fund to strengthen our fund raising capacity.

• Alliance Building: remains a key commitment of EAPN, the 2010 NGO Coalition was a key aspect of the 2010 work, we are also part of collations for the EU Year on Volunteering (2011) and the EU Year on Intergenerational solidarity (2012). EAPN has continued to be active with the Social Platform and Dignity International. WE have developed our contacts with social movements, development NGOs (Action Aid), and Trade Unions (Spring Alliance and Social Conference). We also have strengthened our work with the EU Institutions in particular the Parliament and the EESC.
